## Conditions and Fees for Provision of Sulo Bins and Services

1. **Garbage – Domestic and Recycling Service** (*garbage bin collected once per week and recycling bin collected once per fortnight*) \$262.00 per annum charged via Rates Notice.
  - Compulsory annual charge under Section 496 of the Local Government Act.
  - Applies to all occupied residential properties within the towns and villages where the service is provided.
2. **Garbage – Commercial and Recycling Service** (*garbage bin collected once per week and recycling bin collected once per fortnight*) \$277.00 per annum charged via Rates Notice.
  - Annual charge under Section 501 of the Local Government Act.
  - Applies to commercial properties receiving both the garbage and recycling service.
3. **Waste – Garbage Only Service** (*garbage bin collected once per week*) \$245.00 per annum per bin charged via Rates Notice.
  - Charge for actual use under Section 502 of the Local Government Act.
  - Applies to commercial properties (or rural properties outside of the towns or villages) that wish to receive garbage collection only.
  - Can also apply to residential properties that wish to receive a second garbage service (i.e. they are already receiving the compulsory Garbage – Domestic and Recycling Service at \$257.00 per annum).
4. **Waste – Recycling Only Service** (*recycling bin collected once per fortnight*) \$130.00 per annum per bin charged via Rates Notice.
  - Charge for actual use under Section 502 of the Local Government Act.
  - Applies to commercial properties (or rural properties outside of the towns or villages) that wish to receive recycling collection only.
  - Can also apply to residential properties that wish to receive a second recycling service (i.e. they are already receiving the compulsory Garbage – Domestic and Recycling Service at \$257.00 per annum).

**N.B. Service Availability** – if a new service is requested outside of the currently serviced areas, please confirm with the Environment & Planning Administration that a collection service is available at the location requested prior to completing this form
