- I. I release and forever discharge the Council, its agents, employees and assigns from any actions, costs, claims, and demands which may arise directly or indirectly as a result of the granting of such permit or from any activities which may be carried out by me under such permit.

I acknowledge that Council is not responsible in any way for any injuries to myself or any person or persons, any loss or damage to property or any loss whatever arising directly or indirectly as a consequence of my carrying out or attempting to carry out any activities associated with the above permit.
- III. I indemnify Greater Hume Shire Council from any actions, costs, claims or demands which may arise directly or indirectly as a result of any acts or omissions by me or by any person involved in any operations conducted under or associated in any way with this permit.

Permission is hereby granted to you to collect fallen timber from public roads, (this does NOT include the Hume Freeway, the Olympic or Riverina Highways), with a low or medium conservation status (*see map*), within the Greater Hume Shire pursuant to the Local Government Act 1993 and subject to the following conditions:

- I. The permit costs **\$30** and is **valid for 12 months from the date of purchase**.
- II. Only fallen timber may be collected and **under NO circumstances is standing timber, whether dead or alive, to be removed**.
- III. **Under NO circumstances is there to be any timber collected in the "High Conservation" areas**, which are marked in red on the map provided.
- IV. Collection of timber will not be allowed if it interferes with Council road works.
- V. **Council hereby gives you notice** that in granting such permission to collect timber, it accepts no responsibility for any person or persons who are injured or suffer loss or damage to property, suffer any other loss or damage whatsoever as a consequence of either directly or indirectly carrying out or attempting to carry out any activity or activities related to the collecting of timber pursuant to the permission hereby granted and all persons acting in pursuance of this permission, do so at their own risk.
- VI. **This permit and the roadside conservation map/s must be with the permit holder collecting fallen timber and will be subject to random inspection.**
