ACTION REPORT FROM THE MINUTES

- <u>NOTICE OF MOTION- MOBILE PHONE SERVICE IN GREATER HUME</u> <u>COUNCIL AREA – MINUTE NUMBER 6119 –</u> Cr Meyer requested an update on this matter. The General Manager advised that representation / advocacy has been made directly to Telstra rather than through State and Federal members.. Funding was announced on 16 November 2022, to enable a review of regional phone coverage and representatives from Telstra will be visiting the region and meeting with Council to confirm where specific action is required. The Mayor further added that Andrew Cottrell, Regional Engagament Manager NBN Co is to undertake a survey of NBN coverage across Greater Hume LGA..
